Context

Consent Labs is a pioneering organisation committed to advancing consent education and awareness, particularly focusing on issues surrounding sexual consent. Through workshops, seminars, and online campaigns, they strive to promote the significance of clear, enthusiastic, and ongoing consent in all types of relationships.

Their efforts include developing educational materials, providing training sessions for schools, universities, and community organisations, and collaborating with like-minded organisations.

Additionally, Consent Labs offers resources for survivors of sexual assault and support systems for individuals navigating complex situations involving consent.

Consent Labs' history begins in 2016, when as undergraduates, Angelique Wan and Dr. Joyce Yu conceived the concept of youth-The History led consent workshops after recognising that there was no shared language for discussing consent. They founded Consent Labs, to design and deliver workshops that reflected the ones they wished they had experienced during their high school years. Today, Consent Labs have grown to become recognised leaders in the consent education arena, committed to promoting The Present consent education, and advocacy. With a mission to create a culture of affirmative consent and respect, they work tirelessly to empower individuals to understand and assert their boundaries in all aspects of their lives. At the heart of Consent Labs' initiatives are engaging workshops designed to spark crucial conversations. Whether it's in educational establishments or within communties, their evidence-based curriculum-aligned programs are making waves across Australia with consistent and overwhelmingly positive results. Last year, they secured their inaugural philanthropic grant, which helped attract additional funding from other sources such as from the NSW Department of Communities and Justice.

Advocacy

2023

Consent Labs advocated for systemic change to unify the sexual consent laws across Australia by making a submission and presenting to the Senate Legal and Constitutional Affairs References Committee.

2022

Consent Labs ran a successful campaign - Classify Consent - which encouraged the community to analyse how media shapes our expectations of relationships; calling out the lack of consent depicted on-screen. This garnered 292 pieces of coverage, by publications such as ABC, The Guardian, and SBS, and 6 million views on TikTok.

Consent Labs also led a dialogue with the Australian Classifications Board about the role of classifications.

Angelique started her career at Macquarie Group, but as consent became a national conversation and the need for consent education could no longer be ignored, she took a leap of faith. She started as Consent Labs' first employee and CEO and has not looked back.

Dr Joyce Yu is a junior doctor working in Sydney. Her passion for consent education was born out of her and her peers' lived experiences during university and residential college. Joyce co-founded Consent Labs in 2016 with the goal of bringing together young people and experts to create longlasting cultural change.

Joyce is passionate about gender equity in medicine (and the world),and is currently involved in researching the impacts of pregnancy and parenthood on surgical training in Australasia. She is also interested in medical education, in particular using social media to communicate evidence-based information in an engaging way.

Passionate about improving consent education for the next generation, Julia is an Executive Director, the Company Secretary, and the Head of Legal Research. Currently working in a commercial law firm, and volunteering previously at Youth Law Australia, Julia is committed to becoming a legal advocate for women and children who experience sexual violence.

Julia graduated with a Bachelor of Arts/Laws (Hons I) in 2022 and received first-class honours for her thesis which examined the expansion of judicial directions as a mechanism to transform sexual assault trials. She has since published an article in the Griffith Law Review, titled: Judges as myth-busters: a re-examination of jury directions in rape trials and recently contributed to the Senate Inquiry into the current and proposed sexual consent laws in Australia. She is a passionate advocate for and improving the response of the justice system to sexual offences.

Governance

Structure

Consent Labs (ACN 647 706 232) is a public company limited by guarantee and regulated by the ACNC.

The Company will have no less than three (3) Directors and no more than nine (9).

Tenure

The Constitution allows for tenure of 3 years, with the option to serve 2 terms (maximum of 6 years). Directors who have continuously held office for six (6) years or more may only be re-appointed or reelected by a special resolution.

Board Meetings

Consent Labs' Board Meetings currently meets six times a year using a mix of Zoom and in-person meetings.

Remuneration

Directors receive no remuneration but may be reimbursed for out-of-pocket expenses.



The Opportunity – Non-Executive Directors

Following a period of substantial growth, Consent Labs are entering a new phase of growth and are looking to appoint additional non-executive directors, and possibly a Chair to support their ongoing success and growth.

The Board has transitioned from a startup phase and are now focused on consolidating their growth trajectory, with a strategic emphasis on scaling up their operations. They are seeking experienced Non-Executive Directors, who are young at heart, aligned to the voice of young people, able to command their respect and eager to contribute to this growing business. Importantly, you will bring:

- Strong governance and strategic expertise, ideally in a for-purpose setting.
- Critical experience in accounting or financial management, with sound business acumen, and a proven, unequivocal commitment to achieving goals and comfortably managing the tension between financial and social purpose.
- Familiarity with start-ups and scaling up a small business.
- A willingness and ability to represent and contribute to Consent Labs' image and profile, and to actively work with the CEO to identify and secure new partnerships and funding sources for the organisation to grow its impact. This includes attracting new financial support, strategic alliances and advocates.
- Knowledge of gender-based issues with the capacity and capability to be an active contributor with a genuine interest in Consent Labs and its impact.
- A strong values alignment to Consent Labs' vision, purpose, and mission.

All Consent Labs' current Non-Executive Directors reside in NSW. Given the organisation is intending to establish a presence in Victoria this year, followed by a likely expansion into Queensland within the next 18 months, expressions of interest from individuals located in these States will be viewed favourably.

Consent Labs are also seeking to achieve greater diversity on their Boards, including cultural, gender, disability and LGBTQI+ representation. They welcome expressions of interest from people with expertise in their field and their ability to contribute across the diversity of communities with whom Consent Labs works.
