Context

The Humpty Dumpty Foundation was established to address the critical need for life-saving medical equipment in public hospitals and healthcare services across Australia. Over the past 30 years, the organisation has grown into a trusted partner for healthcare providers, ensuring that children, regardless of where they live, have access to the medical tools required for timely and effective treatment. Driven by a commitment to equity, transparency, and community-focused outcomes, the Foundation remains dedicated to its mission of improving health outcomes for children in need.

As a not-for-profit organisation, the Humpty Dumpty Foundation operates with the support of individual donors, corporate partners, and community advocates. Its innovative Wish List model allows hospitals and health services to outline their most urgent equipment needs, enabling donors to directly fund specific items. This transparent approach ensures that every contribution has a tangible impact, delivering critical resources such as neonatal incubators, paediatric emergency tools, and specialised diagnostic equipment to public healthcare facilities across the country. By addressing these needs, the Foundation empowers medical professionals to provide high-quality care while reducing the disparities faced by children in regional and remote areas.

In addition to supplying equipment, the Humpty Dumpty Foundation supports community and health initiatives designed to improve the quality of care for children. The organisation is overseen by a voluntary Board of Directors and supported by sub-committees in areas such as Finance, Marketing & Fundraising, HR, and Medical Program Advisory. This governance framework ensures that all operations are conducted ethically and efficiently, with a focus on maximising the impact of every donation.

Humpty's Impact



Governance

The Humpty Dumpty Foundation Limited is a not-for-profit public company limited by guarantee, regulated under the <u>Australian Charities and Not-for-profits Commission (ACNC)</u>. Humpty Dumpty Foundation is endorsed as a Deductible Gift Recipient (DGR), covered by <u>Item 1</u> of the table in section 30-15 of the Income Tax Assessment Act 1997.

The foundation operates under a constitution that complies with both the Corporations Act 2001 and the ACNC Act, reinforcing its commitment to responsible governance and financial management.

Composition

The Board of the Humpty Dumpty Foundation must have no fewer than 4 and no more than 12 directors. Directors may be elected by members through resolutions passed at general meetings or appointed by the Board to fill casual vacancies or as additional directors.

Tenure

Directors may serve up to nine years continuously, after which re-election requires a special resolution. A director's term of office generally ends at the annual general meeting, with at least one-third of directors required to retire each year.

Board Meetings

Board meetings are roughly 2 hours every 2 months in Sydney (or virtually if unable to attend in person).

Meeting Dates

2025 Board Meetings are not finalised yet.

Remuneration

This is a voluntary position, and directors are not remunerated. All reasonable expenses incurred by Directors, will be covered.



The opportunity – Non-Executive Director

The primary aims of this position are to collectively govern with other Non-Executive Directors to:

- cultivate a sense of group responsibility with commitment to excellence in governance;
- determine the appropriate culture for the organisation and model behaviours that both reflect and promulgate the desired culture;
- employ the CEO to manage the organisation;
- ensure governance requirements of good working relationships with all stakeholders;
- ensure that the organisation has processes that ensure compliance with all internal and external governance requirements;
- establish and improve procedures and policies to safeguard the organisation's resources, reputation, and public credibility;
- establish the organisation's purpose, values and strategies;
- identify and monitor Quality and Risk across the whole of the organisation;
- monitor performance against KPIs, outcomes and other criteria established from time-to-time drafted by the Board;
- Uphold the following fiduciary duties including the duty
 - to act in the interests of a company as a whole;
 - not to act for an improper purpose;
 - of care and diligence;
 - to retain discretion;
 - to avoid conflicts of interest; and
 - not to disclose confidential information.

Duties and expectations of Non-Executive Directors:

Each Board member must:

- act in a financially responsible manner;
- act in the best interest of Humpty Dumpty Foundation;
- ask for clarification of matters not fully explained;
- attend and contribute to Board meetings and meetings of committees on which they serve;
- critically read and assess all agenda documents before each meeting;
- declare any conflict of interest.
- ensure care, transparency, and diligence in decision making;
- ensure compliance with the Humpty Dumpty Foundation Code of Conduct, and all matters prescribed by law;
- ensure critical review of proposals to the Board;
- · maintain confidentiality;
- seek assurance of compliance with internal and external policies;
- strive to attend all meetings, and notify an apology when unable to attend; and
- undertake diligent analysis of all proposals placed before the Board.

Directors are expected to have an awareness of relevant developments in society, legislation, the not-for-profit sector, and impacts on those who are disadvantaged to enable them to fulfil their responsibilities.



Key selection criteria – Non-Executive Director

Attributes and experience:

The following skills and experience are considered critical to these roles:

- Governance experience Solid experience and qualification in for-purpose and commercial governance.
- Strong financial expertise Qualified accountant (CA or CPA) with 15+ yrs of financial control, accounting, and budgeting experience, ideally with prior treasury experience in the not-for-profit sector.
- Strategic financial planning proficiency in strategic financial decision-making, investment strategy, and long-term financial planning align with HDF's mission.
- Stakeholder engagement strong people skills with experience in motivating and managing teams, evaluating performance, and cultivating connections within corporate Australia, media, or high-net-worth individuals for partnerships or donations.

Further to the above, Humpty Dumpty Foundation is looking for this new NED appointment to come from Sydney, NSW.

In addition, successful applicants will have:

- Proven ability to mentor the CEO and Chair, offering guidance and coaching to enhance financial and commercial acumen and overall organisational leadership.
- Sufficient time and dedication to prepare for and actively participate in board meetings, committee work, and other strategic engagements.
- Valuable networks within the Australian business community, and / or Government.
- A genuine interest in positively contributing to Humpty Dumpty Foundation.
